NOTES:

(A) MAXIMUM AGE LIMIT

- 1. Maximum age limit is **28 years as on 01 Nov 2017**. However, relaxation of age for PWD / Ex-Servicemen will be as per Govt. rules. Maximum age for joining the company will be 56 years after all age relaxations.
- 2. The upper age limit shall be relaxed by five years for internal candidates.
- 3. The relaxation in age limit for PWD candidates shall be applicable irrespective of the fact whether the post is reserved or not.

(B) <u>RESERVATION</u>

- 4. Candidates from reserved category fulfilling eligibility criteria may also apply for the post earmarked for UR as per Government Rules.
- 5. Persons with minimum 40% disability having handicapped certificate issued from Competent Authority can apply in accordance with provision of Para 25 of DOP&T OM No. 36035/3/2004 Estt (Res) dated 29 Dec 05 for the posts not reserved for PWD.
- 6. Category (SC/ST/OBC/PWD) once entered in the Online Application form will not be allowed to be changed and no benefit of other category will be admissible later on.
- 7. SC/ST/OBC candidates applying for this post will be treated as General candidates and no relaxation in any criteria will be applicable to these candidates. However, they may indicate their actual category in Online Application so as to avail of application fees concession as applicable.

(C) WRITTEN TEST

- 8. Written Test will be tentatively scheduled on 14 Jan 2018 (Sunday) at Kolkata.
- 9. No TA will be paid to the candidates for appearing in the written test.

(D) INTERVIEW & SELECTION PROCESS

- 12. Based on the performance in Written Test, candidates will be shortlisted / called to appear for Interview.
- 13. Outstation candidates called for attending the Interview will be paid both ways AC Three Tier Railway fare or actual whichever is less by the shortest route (from place of residence / place of work to Kolkata).
- 14. Final selection of candidates is subject to medical fitness by Company's Medical Officer as per company's Recruitment Rules.

(E) APPLICATION PROCEDURE

- 15. **Online Application Process**: All candidates have to submit application ONLINE through 'Career section' of GRSE website www.grse.nic.in or on https://jobapply.in/grse2017
- 16. All candidates are required to apply ONLINE, take print out of auto generated filled in Application Format, put their signature at designated places and send it along with *GRSE Copy of Application Fee Challan* (applicable for General and OBC candidates) and documents / certificates in support of eligibility to Post Box No. 3076, Lodhi Road, New Delhi 110003 through ORDINARY POST only within the due date of 05 Jan 2018. The envelope containing the application should be super-scribed with "GRSE Employment Notification No. OS:04/2017" and "Assistant Company Secretary".
- 17. Serving candidates of Govt. / Semi-Govt. / PSUs / Autonomous Organization are further required to forward the auto-generated printout through proper channel before the due date of **05 Jan 2018** to the address mentioned at Para 16 or produce No Objection Certificate (NOC) at the time of interview.
- 18. Please note that candidature of the candidate is liable to be cancelled if he/she submits more than one application for same post.
- 19. GRSE will not be responsible for any postal delay.
- 20. Incomplete application is liable to be rejected.

22. All correspondence with candidates shall be done through e-mail only. All information regarding schedule / 'Written Test Admit Cards'/ Interview Call Letters etc. shall be provided through e-mail / uploading on GRSE website. Responsibility of receiving, downloading and printing of written test admit card / interview call letter / any other information shall be of the candidate only. GRSE will not be responsible for any loss of e-mail sent, due to invalid / wrong e-mail ID provided by the candidate or delivery of e-mails to Spam/Bulk mail folder or for delay / non-receipt of information if a candidate fails to access his / her mail / website in time or DND activated mobile no. etc.

(F) APPLICATION FEES

- 23. **Application fees of ₹ 500/- and Bank charges of ₹ 50/- (Total fees ₹ 550/-)** to be deposited through Bank Challan mode at any branch of State Bank of India (SBI) by the applicants (General / OBC only). Applicants belonging to SC / ST / PWD / Internal Candidates are exempted from payment of Application Fee.
- 24. The application fee is non-refundable and hence candidates are advised to ensure their eligibility for the post before applying.

- 26. No other mode of payment will be accepted.

(G) SERVICE AGREEMENT BOND

Candidates joining GRSE in Assistant Manager (Grade-E1) have to execute a Service Agreement Bond to serve the company for 3 years. An amount towards security deposit of 5% of their Basic pay & DA (as applicable at the time of joining) for 3 years which will be deducted from the monthly pay and will be refunded on the completion of 3 years of service including probation period with normal saving bank interest (SBI rates). Bond value will be deductible amount for 3 years. This deposit will be forfeited if the joinee leaves the company before completion of 3 years and will be liable to pay the balance bond amount.

(H) GENERAL TERMS AND CONDITIONS

- 27. The mere fact that a candidate has submitted application against the advertisement and apparently fulfilling the criteria as prescribed in the advertisement would not bestow on him / her the right to be definitely called for interview / considered further for selection process.
- 28. In addition to Basic Pay, Industrial DA (124.30% of BP), HRA (30% of BP) & Perquisites (50% of BP), CPF, Gratuity, Performance Related Pay etc. are admissible as per the Company's Rules. The present CTC per annum in AM (E-1) is ₹7.7 lakhs. In addition, Performance Related Pay will be applicable.
- 29. GRSE reserves the right to fill up all the posts based on suitability or increase/decrease the number of posts to be filled up or cancel any post or even cancel the whole process of recruitment without assigning any reason. In such cases the reservations will be as per the Govt. guidelines.
- 30. Option of Hindi medium shall be given in all selection tests / interview.
- 31. The decision of GRSE in all matters regarding eligibility, conduct of written test, interview and selection will be final and binding on the candidates and no correspondence will be entertained.
- 32. Management reserves the right to call for any additional documentary evidence in support of education, experience etc. of the applicants.
- 33. For any dispute, the Jurisdiction shall be Kolkata.

- 34. Candidate will be allowed for appearing in the written examination / for interview (if shortlisted after written test) presuming that he/she is fulfilling the eligibility criteria and other requirements as advertised in the Employment Notification under reference. In case, at any time, it is found that the candidate is not meeting the eligibility criteria, the candidature will summarily be rejected forthwith. In that event, no reimbursement of travelling expenses incurred for attending the interview will be made. Hence, candidate must ensure that he/she is absolutely meeting the eligibility criteria and other conditions advertised without any deviation.
- 35. If selected, the candidates can be posted to any Unit / Project / location of the company.
