Applications in the prescribed format given at the Commission's website at http:// www.pscwbapplication.in are invited from Indian Citizens and such other nationals as are declared eligible by Govt. of India for recruitment to the under mentioned post at SI. No. 1 which is temporary but likely to be permanent and SI. Nos. 2 & 3 which are permanent.

N.B.: ABILITY TO READ, WRITE AND SPEAK IN BENGALI IS AN ESSENTIAL QUALIFICATION FOR RECRUITMENT TO ALL POSTS AND SERVICES MENTIONED BELOW. PROVIDED THAT THE SAID COMPULSORY REQUIREMENT OF KNOWLEDGE IN BENGALI IS NOT APPLICABLE FOR THOSE CANDIDATES WHOSE MOTHER TONGUE IS NEPALI UNLESS MENTIONED OTHERWISE AGAINST ANY PARTICULAR POST(S). THIS WILL BE TESTED AT THE TIME OF INTERVIEW.

1. PROBATION-CUM-AFTER CARE OFFICER UNDER THE DEPARTMENT OF CORRECTIONAL ADMINISTRATION, GOVT. OF W.B. IN WEST BENGAL GENERAL SERVICE: NINE (1 each reserved for OBC-A & OBC-B & 3 for S.C.).

**PAY:** P.B.-4, Rs. 9,000/- - Rs.40,500/- with Grade Pay Rs. 4,400/-.

### **QUALIFICATIONS:**

- (i) Degree of a recognised University or its equivalent;
- (ii) Administrative experience or experience of social Welfare work for at least two years.

AGE: Age between 30 and 40 years on 01.01.2018.

**N.B.:** Probationary period : Two years.

2. MEDICAL TECHNOLOGIST (ECG) Grade-III IN THE DIRECTORATE OF EMPLOYEES' STATE INSURANCE (MEDICAL BENEFIT) SCHEME UNDER THE LABOUR DEPARTMENT, GOVT. OF W.B. – FIFTEEN [3 reserved for OBC-A, 2 for O.B.C.-B, 7 for S.C and 1 each for S.T & P.D.(Blindness or Low Vision)].

**PAY:** (P.B.-3) Rs. 7,100/- - Rs. 37,600/- with Grade Pay Rs. 3,600/-.

### **QUALIFICATIONS:**

- i) <u>Essential</u>: Passed Higher Secondary Examination of the West Bengal Council of Higher Secondary Education or its equivalent with Physics, Chemistry and Biology and a two year Diploma in ECG Technology recognized by the Government of West Bengal.
- ii) Desirable:-
- a) One year training after acquiring Diploma in ECG Technology recognized by the Government of West Bengal, in any government Hospital or in a Clinical Establishment licensed under the West Bengal Clinical Establishment Rules, 2003.

b) A Post-Graduate Diploma in ECG Technology from a recognized University.

AGE: Not more than 39 years on 01.01.2018.

3. MEDICAL TECHNOLOGIST (LABORATORY) Grade-III IN THE DIRECTORATE OF EMPLOYEES' STATE INSURANCE (MEDICAL BENEFIT) SCHEME UNDER THE LABOUR DEPARTMENT, GOVT. OF W.B. – SIXTY SIX [7 reserved for OBC-A, 5 for O.B.C.-B, 15 for S.C, 4 for S.T., 2 for Meritorious Sportsperson and 1 each for P.D.(Hearing Impairment) & P.D.(Loco-motor Disability or Cerebral Palsy)].

PAY: (P.B.-3) Rs. 7,100/- - Rs. 37,600/- with Grade Pay Rs. 3,600/-.

#### **QUALIFICATIONS:**

i) <u>Essential</u>: Passed Higher Secondary Examination of the West Bengal Council of Higher Secondary Education or its equivalent with Physics, Chemistry and Biology and a two year Diploma Course in Laboratory Technology recognized by the Government of West Bengal or one year Diploma Course in laboratory Technology from any University / Institution recognized by Government of West Bengal where basic qualification for undergoing the said Course is B.Sc.

### ii) Desirable:-

a) One year training after acquiring Diploma in LaboratoryTechnology recognized by the Government of West Bengal, in any government Hospital or in a Clinical Establishment licensed under the West Bengal Clinical Establishment Rules, 2003.

<u>Or</u>

b) A Post-Graduate Diploma in Laboratory Technology from a recognized University.

AGE: Not more than 39 years on 01.01.2018.

Fee: Rs. 160/- (Rupees one hundred sixty) only. In addition to that, the candidates will be charged as follows:

S.C./S.T. candidates of West Bengal and Persons with disabilities (P.W.D.) having physical disability of 40% and above are not required to pay any fee. BC candidates of West Bengal are, however, required to pay usual fee as aforesaid. NO EXEMPTION OF FEE IS AVAILABLE TO S.C./S.T. CANDIDATES OF OTHER STATES AND B.C. CANDIDATES. No claim for refund of the fee will be entertained nor will it be held in reserve for any other examination.

# INFORMATION

- 1. Candidates who wish to apply for more than one category of posts should submit separate Application along with requisite fees for each.
- 2. SUBMISSION OF MORE THAN ONE APPLICATION FOR ONE PARTICULAR POST IS STRICTLY FORBIDDEN. THE CANDIDATURE OF A CANDIDATE WHO SUBMITS MORE THAN ONE APPLICATION FOR ADMISSION TO THE SELECTION PROCEDURE, WILL BE CANCELLED EVEN IF HE/SHE IS ADMITTED TO THE SAME.
- 3. The qualifications prescribed in the advertisement are as per the notified recruitment rules issued by Government.
- 4. All the degrees/diplomas/certificates mentioned in the advertisement must have been obtained from recognized Universities/Institutions.
- 5. The prescribed 'essential qualifications' are the minimum and mere possession of the same does not entitle applicants to be called in for the interview. Where the number of applications received in response to the advertisement is large and it is not convenient or possible for the Commission to interview all the applicants the Commission may restrict the number of candidates for interview to a reasonable limit on the basis of either higher qualifications in the relevant subjects/higher standard of marks/grade obtained in the essential qualifications or experience in relevant field higher than the minimum prescribed in the advertisement or on the basis of a Screening Test/Written Test. The Commission may fix qualifying cut-off marks for all the categories of the vacancies in each level of examination, i.e. written, interview and aggregate.

IN THE CASES OF SCREENING TEST/ WRITTEN TEST, CANDIDATES SUFFERING FROM BLINDNESS OR LOW VISION WILL BE ALLOWED THE HELP OF A SCRIBE, IF REQUIRED. THE SCRIBE SHOULD NOT POSSESS EDUCATIONAL QUALIFICATION HIGHER THAN THE REQUISITE QUALIFICATION FOR THE POST.

If sufficient number of candidates with prescribed age limit is available for selection for a particular post, the commission may exercise its discretion not to relax upper age limit of the candidate(s) even if the provision for such relaxation is laid down in the advertised criteria.

- 6. In cases where no Division/Class is awarded and only grading is done, exact percentage of marks and conversion formula adopted are to be mentioned with documentary evidence, if required.
- 7. Where experience of a number of years is prescribed as an item of qualification this would mean only experience/research experience gained in full time employment/research in the relevant field within the closing date of receipt of applications.
  - [Certificate(s) from the Head(s) of the Organisation(s)/Department(s) or Competent Authority for the entire experience claimed, clearly mentioning the duration of employment (date, month and year) and field of experience indicating basic pay and consolidated pay must be obtained from the appropriate authority. The certificate(s) should also mention the nature of duties performed/experience obtained in the post(s) with duration(s)].
- 8. Besides pay, the posts carry allowances as admissible.
- 9. The benefits of reservation of vacancies and upper age concession upto 5 years are admissible only to S.C. and S.T. candidates of West Bengal and upto 3 years to O.B.C. (category 'A' & 'B') candidates of West Bengal. S.C., S.T. and B.C. candidates of other States may apply for unreserved vacancies as general candidates. Such benefits are also available upto the age of 45 years for Persons with disabilities
  - (a) A candidate claiming to be S.C., S.T., B.C. or persons with disabilities (40% and above) must have a certificate in support of his/her claim from a competent authority of West Bengal as specified below:

#### For S.C., S.T. and B.C. candidates:

- (i) In the district, the Sub-Divisional Officer of the Sub-Division concerned, and
- (ii) In Kolkata, the District Magistrate, South 24-Parganas or such Additional District Magistrate, South 24-Parganas, as may be authorized by the District Magistrate, South 24-Parganas, on behalf and the District Welfare Officer, Kolkata and Ex-officio Joint Director, Backward Classes Welfare.
