West Bengal State Health & Family Welfare Samiti will engage personnel purely on contractual basis for the Position of **State Consultant (Quality Nursing)** in **Quality Assurance Programme** under **National Health Mission**, Department of Health and Family Welfare, Government of West Bengal.

Eligible candidates should apply online in the prescribed format as given in Department's Website from 11 am of 30th January, 2019 to Midnight of 15th February, 2019, for the mentioned position.

Only online applications will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled. Application fees of ₹100/ have to be deposited through on-line/off-line mode. The amount is non-refundable (Details of on-line/off-line mode, payment details and important dates are given in General Information point no. 9&10)

All the essential criteria must be completed on or before the first date of online application.

Name of the Position: State Consultant – Quality Nursing

Number of Vacancy : 1 (Unreserved)

Remuneration : ₹ 50,000 per month.

Place of Posting : State Head Quarter.

Essential Qualification: i) M. Sc. in Nursing from a recognised University duly recognised by Indian Nursing Council and any State Nursing Council.

ii) **Must be registered with West Bengal Nursing Council.**

iii) Knowledge of Bengali and English –both speaking and writing skill.

Desirable Qualification : Must have proficiency and skill in basic computers and should have skill in using MS Word and MS Excel Programmes and internet.

Essential Experience: A minimum of 5(five) years of teaching experience in a School of Nursing or College of Nursing duly recognised by Indian Nursing Council and any State Nursing Council.

Desirable Experience: Experience of working as Principal of a Nursing School or College for a minimum period of 2 (two) years as on the date of application.

Age (as on 1.1.2018) : Not more than 62 years.

Scale of Scoring - Total 50 Marks

- **Educational Qualification -10 Marks**
M.Sc. Nursing - 10 Marks (Proportionate Marking i.e % obtained in the exam *10/100)
- **Experience – 20 Marks**

- a) 1 (One) mark will be allotted for each completed year of teaching experience in a School of Nursing or College of Nursing, duly recognised by Indian Nursing Council and any State Nursing Council upto a period of maximum of ten years.-10 marks
- b) 5 (Five) marks will be allotted for each completed year of experience working as Principal of a Nursing School or College, upto a period of maximum of 2 years.-10 marks
- Computer Test - 10 Marks
 - Interview - 10 Marks

Applications found correct in all respect on the basis of on-line data submitted by the candidates will be shortlisted based on the essential qualification (Academic Qualification and Experience) in the 1:20 ratio for verification. Thereafter, candidates who fulfil all the criteria may be called for computer test and Interview.
Candidates must obtain at least 60% marks in Computer Test to qualify for Interview.

General Information for the Applicants/Candidates

1. Only online Applications will be accepted. **Application forms not properly filled in or incomplete Application forms are liable to be cancelled.** If the online application details submitted by the applicant differ with the original testimonials, that application shall be liable to be cancelled.
2. If proper signature and photograph are not uploaded at the time of online application that application shall also be liable to be cancelled.
3. The Essential Qualifications mentioned are the minimum and mere possession of the same does not entitle the candidate to claim selection. **All the essential qualification must be completed within the first date of online application.**
4. Experience will be calculated after obtaining the required essential qualification for the above mentioned position, till the first date of online application.
5. Hard copy/print copy of the online registration/ application form (printed within the last date of on-line application), should be retained by all applicants for document verification purpose. Without registration/application form, no candidates will be entertained for original testimonials verification by the authority. No need to send Hard copy/print copy of the online registration/application form by post.
6. On-line registration No. should be retained by all applicants for future reference. Employer is not liable to give any information regarding the on-line registration no. in future.
7. No **rounding off** of marks will be granted. Proportionate marking upto 2 decimal points will be considered.
8. **Registration certificate of West Bengal Nursing Council must be issued on or before first date of online application.**
9. i) Last date of Registration : Midnight of 7th February, 2019, 2019
ii) Last date of Submission of application Fees : 12th February, 2019 (upto banking hours for off-line payment mode)
iii) Last date of full Submission of form : Midnight of 15th February, 2019

10. The online deposition of application fees can be done through net banking or credit/debit card system through an online interface. If the payment is successful, the candidate will be immediately reverted back to the link for final submission of the application form by using the application id already received at the time of Registration.


If the candidate wants to submit the requisite fee through offline mode he/she can do so with system generated e-challan. The fee can be deposited in any branch of United Bank of India (UBI) with the print out of the system generated e-challan after duly filling up the three parts of the challan. Out of the three parts of the challan, bank will keep one part and hand over the other two parts to the candidate. Candidates must preserve both copies with him/her for future reference.

The candidates can complete the procedure of final submission of application form within 2 subsequent working days from the date of deposition of the offline fees by using the application id already received at the time of Registration along with the transaction id obtained from the bank.

Please do not deposit fee in more than one mode or more than once in one mode.

11. The candidates, if found ineligible after verification process, will not be called for the subsequent stages of the selection process.

12. The decision of the competent authorities regarding the recruitment is final.
