Sub-: Filling up the post of Dy. Chief Hydraulic Engineer by
absorption through composite method at KoPT –
applications invited.

Applications are invited for filling up of one vacancy in the post of Dy. Chief Hydraulic Engineer in the scale of pay of Rs. 32,900- 58,000/- in the rank of Dy. HOD, through composite method.

2. As per Recruitment Rule, the post is to be filled up by absorption through composite method. Officers holding ANALOGOUS POSTS or the post of Dy. Director and equivalent posts in HSD, in the scale of pay of Rs.24, 900-50,500/- with 3 years regular service in the grade in a Major Port Trust or Dy. Director and equivalent post in Hydraulic Study Department with 2 years regular service in the grade and a combined regular service of 7 years in the scale of pay of Rs. 20,600-46,500/- and Rs. 24,900-50,500/- in Hydraulic Study Department of any Major Port Trust having requisite qualification as per enclosed RR (Annexure-1) will be eligible.

3. The selection is by merit for which overall grading in the ACRs/APARs will not be below "Very Good"

4. Applications of willing and eligible officers, who satisfy the provisions of the Recruitment Rules (**Annexure-I**) for the post of Dy. - ii) Attested copies of all the certificates and proof of educational qualification, present and past work experience in the respective post and pay scale.
- iii) No objection certificate from the respective Port.
- iv) Undertaking of the applicant to the effect that the candidature will not be withdrawn, if selected.
- v) Vigilance and administrative clearance by the concerned Port (**Annexure-III**)
- vi) Passport size photographs (two numbers).

5. If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application.
