- (i) A recognized medical qualification included in the First or Second Schedule or Part-II of the Third Schedule to the Indian Medical Council, Act, 1956. (Holders of educational qualifications included in Part-II of the Third Schedule should also fulfill the conditions stipulated in section 13 (3) of the said Act);and
- (ii) A post graduate qualification e.g MD (Doctor of Medicine )/ MS (Master of Surgery) or a recognized qualification equivalent thereto in the respective subject or allied discipline.
- (a) Four years teaching experience as Assistant Professor in the concerned specialty in a recognized medical college with minimum of two research publications in indexed or national journals provided that these research publications are published or accepted for publication in the Journals by the National Associations or Societies of the respective specialties as the First or Corresponding Author, and further provided that the requirement of two research publications for promotion to the post of Associate Professor should be fulfilled with two research publications must be published during the tenure of the Assistant Professor.

Note 1: The experience should be recognized by the Medical Council of India or the statutory body concerned with the system of medicine as valid teaching experience for teaching posts and certificate thereof or any other valid proof in support thereof should be submitted and a certificate to this effect is to be submitted.

Note 2: Teaching experience in any other post like the post of General Duty Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.

  - a) Three years teaching experience in the subject as Resident/ Registrar/ Demonstrator/Tutor in a recognized medical college either during the post graduation course or after obtaining postgraduate degree in the subject.
  - b) One year as Senior Resident in the concerned subject in a recognized/Permitted medical college.
  - c) Provided that in disciplines where the post of Senior Resident is not prescribed in the applicable Minimum Standard Requirements for the Medical College for 100 Admissions Annually Regulations one year experience as Tutor/Demonstrator/Resident/registrar after obtaining Post Graduate Degree in the concerned discipline shall be required.
- ii. <u>Equivalence of qualification of DNB (broad specialties) with</u> MD/MS:
  - a) Those candidates who have undergone DNB training in an institution which now run MCI recognized postgraduate degree courses in a given subject, their DNB qualifications shall be considered at par with MCI recognized qualifications that subject only.
  - b) One year as Senior Resident in the concerned subject in a recognized/Permitted medical college.
  - c) Provided that in disciplines where the post of Senior Resident is not prescribed in the applicable Minimum Standard Requirements for the Medical College for 100 Admissions Annually Regulations one year experience as Tutor/Demonstrator/Resident/registrar after obtaining Post Graduate Degree in the concerned discipline shall be required.
- iii. Additional training of one year for equivalence of qualification of DNB (broad Specialties) with MD/MS:
  - a) Those candidates who have undergone DNB training in broad specialties in hospital/ institution other than mentioned in (ii) above, shall undergo one additional year of senior residency or equivalent training or research job in a MCI recognized hospital/ institution, provided such qualifications are notified in the Postgraduate Medical Education Regulations 2000".
  - b) One year as Senior Resident in the concerned subject in a recognized/Permitted medical college.
  - C) Provided that in disciplines where the post of Senior Resident is not prescribed in the applicable Minimum Standard Requirements for the Medical College for 100 Admissions Annually Regulations one year experience as Tutor/Demonstrator/Resident/registrar after obtaining Post Graduate Degree in the concerned discipline shall be required.

- 4. Retired candidates from Central/ State Govt. / PSU from the equivalent posts are eligible to apply. Persons working in recognized/ approved Private Medical Institutions fulfilling eligibility criteria for the post may also apply.
- 5. The candidates have to attach the self-attested copies of all the relevant certificates/ testimonials on support of date of birth (Secondary exam certificate/Admit Card), category, sub-category i.e. educational qualification, teaching experience, Pension Payment Order (PPO), etc. with the application form and have to **produce originals** thereof at the time of Walk in Interview.

### C. TERMS OF CONTRACT:

The engagement will be for a period till the joining of regular incumbent. The contract would initially for one year, to be extendable for another one year on satisfactory performance, with a minimum term of one year in respect of teaching faculty or attaining the age of 70 years whichever is earlier.

\*\*Although those posts are reserved for SC, ST, OBC category, in case of non-availability of the candidates of appropriate category, candidates from other category can be considered for appointment on contractual basis for period of less than 45 days.
