Vidyasagar University invites application from Indian Nationals for filling up of the following posts mentioned below.

1. Assistant Professor (Purely on contract basis) in Electronics: 1 (One) Post (Unreserved). Consolidated pay (Pre Revised): Rs. 21,600 and other allowances as admissible.

## Minimum Eligibility Criteria:

### **For Assistant Professor:**

a. Good academic record as defined by the concerned University with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) attheMastersDegreelevelinarelevantsubjectalongwithrelaxationapplicableto specifiedcategoriesasexplainedintheNote-1.

b. the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or similar test accredited by the UGC like NET/SET along with exemptions to specified categories as explained in the **Note – 2**.

### Note-1: Relaxation of Marks for Recruitment of Assistant Professor:

- *i.* A relaxation of 5% may be provided at the Graduate and Masters level for the Scheduled Castes/Scheduled Tribes/Differently-abled (physically and visually differently-abled) / other Backward Classes (non-creamy layer) categories for the purpose of eligibility and for assessing food academic records during direct recruitment to teaching positions. However, differently-abled (physically and visually) candidates are not eligible for any marks relaxation in Physical Education discipline.
- *ii.* The minimum qualifying marks of 55% is relaxable by 5% marks (from 55% to 50%) at the master level for Ph.D. degree holders who have obtained the Masters degree prior to September 19, 1991.
- *iii.* The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.

*iv.* All the essential qualifications must have been obtained from a recognized University/ Institute. By a recognized University/ Institute is meant a University/ Institute affiliated to UGC / other statutory apex bodies, or recognized by the State or Central Government as a centre of higher learning. In case of a foreign University, the Degree concerned should be recognized as equivalent to its India counterpart by the Association of Indian Universities.

## Note-2: NET/SLET/SET Exemption for the Post of Assistant Professor:

- i. The candidates who have been awarded Ph.D. degree in the same or in a relevant subject in accordance with the University Grants Commission (Minimum Standards and Procedure for award of Ph.D. Degree) Regulations, 2009 shall be exempted from the qualifying in the Eligibility Test (NET/SLET/SET).
- ii. Candidates registered for Ph.D. programme prior to 11 July, 2009 shall be exempted from qualifying in the Eligibility Test (NET/SLET/SET) as described hereinafter. The award of Degree to candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye laws/ Regulations of the institutions awarding the Degree in the same or relevant subject shall be exempted from the requirement of NET/SLET /SET. Subject to fulfillment of the following conditions:
  - a) Ph.D. degree of the candidate awarded in regular mode only;
  - b) Evaluation of the Ph.D. thesis by at least two external examiners;
  - c) Open Ph.D. viva voce of the candidate had been conducted;
    - d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a referred journal;
    - e) Candidate has made at least two presentations in conferences, seminars, based on his/her Ph.D. work.
- f) (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean (Academic Affairs)/Dean (University instructions).

iii. NET/SLET/SET shall also not be required for such Master's Programmes in disciplines for which NET/SLET/SET is not conducted.

2. Nursing Staff (Purely on contract basis): 1 (One) Post (Unreserved). Consolidated pay (Pre Revised): Rs. 13,400 and other allowances as admissible.

#### **Essential Qualifications:**

ANM/GNM from any institute approved by Indian Nursing Council and West Bengal Nursing Council or by State Nursing Council other than West Bengal.

**Desirable:** Post qualification experience in oxygen saturation monitoring, oxygen cylinder handling for patient ventilation, handling of nebulizer, care of patient and other related jobs in University Medical Unit.

3. Medical Assistant (Purely on hiring service basis): 1 (One) Post (Unreserved).

**Pay:** As per the norms of the University

### **Essential Qualifications:**

M.Sc. in Biomedical Laboratory Science and Management or M.Sc. in MLT or Bachelor in MLT from any University or University approved institute recognized by Central/ State Govt.

**Desirable:** Post qualification experience for 6<sup>th</sup> months in the field of sample collection, sample analysis, patient care and patient monitoring. Working knowledge in computer handling

- 5. The period of time spent by the candidates to acquire M.Phil and Ph.D degree shall not be claimed or considered as teaching/research experience for appointment to the post of Associate Professor / Professor.
- 6. OBC-A, OBC-B, SC, ST, EC certificate, (as the case may be, if applicable) issued by the competent authority of Govt. of West Bengal only, will be considered.
- 7. Persons employed in Government / Semi Government Organizations / Autonomous Bodies should submit their application through proper channel. They may, however, send an advance copy of the application. Those who are unable to process their application through proper channel may submit 'No Objection Certificate (NOC)' from present employer during the time of interview. However, they should submit an undertaking to that effect. Direct application from such candidates will not be entertained.
- 8. Age relaxation for SC/ST/OBCs/Ex-Serviceman and Persons with Disabilities (PWD) is applicable as per Government norms. Age relaxation is also applicable those are working at Vidyasagar University.
- 9. Candidates should submit their SC/ST/OBCs/ Ex-Serviceman, Disability Certificate issued by Competent Authority in the prescribed format along with the application form, in support of their claim.
- 10. The University reserves the right of rejecting any or all the applications without assigning any reasons thereof.
