iv) **AGE RELAXATION:** Upper age limit as per existing Central Government rules.

vi) Candidates employed in Govt. Departments / PSUs / Autonomous Bodies will have to produce No Objection Certificate (NOC) at the time of Document verification otherwise their candidature will not be considered.

vii) Category i.e. UR/SC/ ST/ OBC/ PWD, once entered at the time of online registration, cannot be changed under any circumstances and no benefit of other category will be admissible later on.
