

**Advertisement for the Post of Project Associate for Collaborative Research Project by NUJS, IIT KGP,  
IIT Kanpur and IISER Kolkata**

Applications are invited for the post of **Project Associate** for a collaborative research project titled '**NyayKosh: Multilingual Resources for AI-based Legal Analytics**', jointly conducted by NUJS, IIT Kharagpur, IIT Kanpur and IISER Kolkata and sponsored by the AI4ICPS Hub, IIT Kharagpur. The position is a **full-time** one and the selected candidate shall have to work **physically out of the NUJS campus** in Kolkata, with outstation visits for data collection purposes as and when necessary. The selected candidate will be paid a monthly salary of **INR 31,000/- together with 24% HRA** as per norms. The selected candidate will be offered the position for an initial period of **6 (six) months**. Subject to satisfactory performance on the candidate's part, the contract may be further renewed for the full duration of the project i.e. **2 (Two) years**.

**Essential Qualifications:**

1. LL.M. with a minimum of 55% marks or equivalent grade. (Candidates who have relevant industry and/or research experience of a minimum of 2 years, with a 3 Year LL.B. degree or a 5-Year integrated B.A./B.Sc./BBA./B.Com. LL.B. (Hons.) degree or equivalent may also apply, as may candidates who may already have appeared for their LL.M. final year examination and awaiting their result).
2. Demonstrable interest in the field of law and technology, legal research and publications.
3. Familiarity with existing legal databases such as Manupatra, SCC Online, Indian Kanoon, India Code, Westlaw, Hein Online, LexisNexis, JSTOR, together with regulatory websites such as those maintained by the RBI, SEBI, CCI, TRAI, PNGRB etc. and websites maintained by the various ministries and departments on central and state levels in India.
4. Proficiency in English and working knowledge of either Hindi and a regional language, or two regional languages.
5. Familiarity with using computers and electronic devices including programmes such as MS Office.

**Desirable Qualifications:**

1. Demonstrable interest in the domain of usage of AI and sub-domains like NLP, ML, IE & IR and related techniques in the field of law.
2. Relevant quality publications.
3. Proficiency in two or more regional languages.
