One year diploma course in Laboratory Technology from any University/ Institution recognized by the Government of West Bengal ; where basic qualification for undergoing the said course is B.Sc. in the

- (ii) **Desirable:** One year training after acquiring diploma in Laboratory Technology recognized by the Government Hospital or in a Clinical Establishment Licensed under West Bengal Clinical Establishment Rules 2003.

b) Age limit:

Not less than 18 years and not more than 37 years on the 1st January of the year of advertisement. Provided that the Provisions of West Bengal Services (Raising Age Limit) Rules, 1981 shall apply as long as the same remain in force.

Provided also that age may be relaxed for the candidates belonging to the categories of Scheduled Cast, Scheduled Tribes and other Backward Classes as per Government Rules or orders from time to time.
